Update from the Santa Fe Film Office (SFFO) – 4:10 pm

The SFFO is led by Eric Witt who served the administration of New Mexico Governor Bill Richardson as Deputy Chief of Staff; Director of Legislative/Political Affairs; and Director of Media Industries Development from 2003 – 2010. During his term, he guided the growth of the film and television industry in New Mexico from \$8 million in 2002 to over \$4 billion by 2010. In addition to expanding production, he also oversaw the establishment of statewide crew training programs, educational and business development, and community outreach efforts -- programs which subsequently have become global standard practices. Prior to public service, Eric worked in Los Angeles as a film and television executive in production & corporate finance for a number of entities including Dino De Laurentiis Communications, as well as in sales, distribution and ancillary product development. He was also one of the co-founders of Asylum Entertainment, a leading-edge developer of multi-platform entertainment properties. Since returning to the private sector in 2011 he has worked with state and national governments, major studios and independent production houses regarding film/television production, sporting events and related incentive programs.

Jennifer LaBar is the program administrator for the SFFO who brings extensive experience in both local and regional government, problem solving, community relations and, as a bonus, the premium hospitality industry. Believe us when we say she lends a unique and highly effective perspective and range of capabilities to the Film Office. Jennifer engages daily communications with productions,

acts as an interface between productions and various government entities and local communities, and is an all-around resource for information from the mundane to the arcane. This includes permitting coordination, public lands and buildings site requests, and other special production needs as they arise.

The SFFO works directly with a third of the productions that happen in Santa Fe. The SFFO is a joint city/county office working together to service productions in Santa Fe. The Santa Fe Film Commission was unanimously approved by the City Council and sponsored by Mayor Javier M. Gonzales to create a Santa Fe Film Commission in order to expand and enhance the city's film and digital economy. The Commission's goals are to: enhance recognition as a desirable filmmaking destination, and increase production in Santa Fe; Increase post-production and other digital media business as a sustainable industry in Santa Fe; Diversify the industry base by growing local productions and other complimentary businesses in Santa Fe; Foster a sustainable year-round industry, that employs a skilled workforce in high-wage jobs; Facilitate increased production spending at local businesses, and evaluate potential areas of investment and resource allocation and make recommendations on priorities.

A recently new entity in Santa Fe include the Stagecoach Foundation who mission is to offer an paralleled, executive suite-style office space in an amazing LEED- certified building located near the legendary Santa Fe Plaza and to bridge skill and talent, resource and community, by engaging incredibly talented crew members from resident film productions and tech companies with free educational workshops, mentorship and master-class programs for underserved youth and young adults so they can pursue their dreams in the film and tech industries.
