Being able to quickly and competently make critical emergent decisions and execute life saving maneuvers "successfully" and independently has been an amazing experience and a career validator. Detox by Detention, as I call it, is a slippery slope with no boundaries. Hard as it might be to believe, people aren't always forthright or accurate reporters of either historic or immediate behaviors. Then there's the onset of diabetic, respiratory and cardiac chronic disease process exacerbations from those that forgot to mention they take meds, and, it goes without explanation, the existence of grim potentials always looms without limits. This unique nursing role has been unbelievably generous providing opportunities to reinforce the standards of care as well as forging into formerly unexperienced territories. Being non judgmental regarding another human beings life circumstances is a must .. some young people and mentally ill never even got a fair chance to survive and thrive. We need more programs and funds to help some of the broken piece a safe clean life together.
