Approval of Agenda – 1:07 pm

Chairperson Alicia Keyes Touche asked for a motion to approve the agenda. A motion was made by Council Member Ann Lerner and seconded by Council Member Teri Farley. Motion carried.

Approval of Minutes – 1:08 pm

Chairperson Alicia Keyes Touche asked for a motion to approve the May 8, 2014 meeting minutes. A motion was made by Council Member Chris Eyre and seconded by Council Member Talia Kosh. Motion carried.

City of Santa Fe Mayor Javier Gonzales – 1:08 pm

Councilmember Chris Eyre invited Santa Fe Mayor Gonzales to the GCFMI meeting to open communication with the Mayor and the GCFMI Council. The GCFMI would like Mayor Gonzales to consider the council as a resource.

Mayor Gonzales: There is incredible creativity in NM. The film program at the Santa Fe University of Art and Design film has 350 students. This industry is a great pipeline for jobs in New Mexico. We want New Mexico to be the place for film and television productions. Film Tourism is important to our economy as we have seen with successful productions such as "Breaking Bad," "Manhattan" and "Longmire." How do we create the next generation of filmmakers in New Mexico? The city of Santa Fe is looking at active partnership with Santa Fe County in its film and television efforts.

Chairperson Alicia Keyes Touche: Who should we work with in your office regarding questions on Santa Fe film and Santa Fe film tourism? Mayor Gonzales: Work with Kate Noble in our office (phone: 505-955-6915 email: kinoble@santafenm.gov).

Shoot Santa Fe: Kate Noble, Acting Director Housing and Community Development Department; and Special Projects Administrator Economic Development Division and David Griscom, Santa Fe County Film Liaison – 1:26 pm





Shoot Santa Fe was created as a city of Santa Fe initiative to work with private businesses, unions and the Santa Fe County on film, TV and the digital economy in the northern New Mexico region.

David Griscom: It would be helpful to see a breakdown of the tax credit and the economic impact by County. Would like to discuss the rolling CAP with the GCFMI Council.

Nick Maniatis, Director of the New Mexico Film Office: We have figures broken down by zip code. These numbers are estimates not actuals.

New Mexico Film Office (NMFO) update – 1:40 pm

Nick Maniatis, Director of the New Mexico Film Office: The first phase of the film study was completed this past June to look at the economic and community impacts, and cost-effectiveness of the New Mexico film production tax incentive. This is the first of four phases. New Mexico has become a well-established and important production location for film and television. The average wage of film and TV employees is over \$52K. These are considered a high-wage jobs in New Mexico.

A motion was made by Council Member Rick Clemente to establish an exploratory committee to form an opinion on the CAP. This motion was seconded by Council Member Steve Rooney. Motion carried. Council Member Rick Clemente volunteered to head up the exploratory committee.

The NMFO's emerging media contractor is working to finalize the plans for the accelerator. There is a venture capital firm in California and in New Mexico who are interested in working with this initiative. The NMFO is considering having an accelerator in Albuquerque and in Santa Fe.

Production update: there are 7-9 television series shooting in New Mexico. There are more pilots coming to NM in the next coming months. The whole state is benefiting from film and TV in New Mexico.

Director Maniatis will be attending the October Motion Picture Association Film Commissioner Summit in Washington, DC and the annual Association of Film Commissioners International Cineposium in New York to host a panel on "How to Swim in Legislative Waters": Whether you're looking to create or modify a tax incentive, establish or sustain a film commission, or alter local costs like permit fees or police and fire support, you'll need a specific set of skills. We'll address how to approach legislators, address committees, build a coalition, use effective language, and debate the issues.

Lindsey Valdez, Local Outreach Programs Manager: The Student Training and Research Society/S.T.A.R.S website has been built and is not viewable to the public. The NMFO will host its second annual Film & Media Education Summit on October 4th in Albuquerque at the National Hispanic Cultural Center. The mission of this event is to stimulate communication and coordination between New Mexico's film and media industry and secondary and higher education institutions, thus, establishing a well-defined educational environment that offers cutting edge training for today's competitive industry. The event is open to administrators, educators, guidance counselors and advisors from the secondary and higher education levels. A sub-committee has been formed to create the agenda and topics to be discussed.

Recently the NMFO presented to the New Mexico Municipal League in Albuquerque regarding film and TV productions in New Mexico. The New Mexico Municipal League consists of 105 members statewide which include elected officials, mayors and city officials.

The NM Filmmakers Showcase call for entries press release will be announced later this week. The NM Filmmakers Showcase will be held in Santa Fe at the Jean Cocteau Cinema on January 24-25, 2015. The Showcase is an annual event featuring a vast range of creative local talent from around the state. There is no charge to submit an entry and all screenings are free to attend. A panel of industry professionals will be judging the following eight categories: Animation, Comedy, Documentary, Drama, Experimental, Fantasy/Sci-fi, Horror, Other. "Best of Category" winners will be screened on Saturday, January 24, with a reception to follow where attendees will have the opportunity to meet the filmmakers and judges. Other entries will be screened on Sunday, January 25, on a

first-come-first-served basis by category. Winning Showcase films will travel the state, being screened at a number of local festivals throughout New Mexico in 2015.
